A public meeting of the Cambridge City Council’s Public Safety Committee was held on Tuesday, April 7, 2026. The meeting was Called to Order at 11:00 a.m. by the Chair, Councillor Al-Zubi Pursuant to Chapter 2 of the Acts of 2025 adopted by Massachusetts General Court and approved by the Governor, the City is authorized to use remote participation. This public meeting was hybrid, allowing participation in person, in the Sullivan Chamber, 2nd Floor, City Hall, 795 Massachusetts Avenue, Cambridge, MA and by remote participation via Zoom.

At the request of the Chair, Clerk of Committees Erwin called the roll.

Chair Al-Zubi offered opening remarks (**Attachment A**) and noted that the Call of the meeting was on the Cambridge Police Department’s federal immigration enforcement tracker, which was referred to the Public Safety Committee for discussion, CMA 2026-32. Present at the meeting from the Cambridge Police Department (CPD) were Superintendent Pauline Wells, Superintendent Frederick Cabral, and Deputy Superintendent John Boyle. Present from the Law Department was City Solicitor, Megan Bayer and First Assistant City Solicitor, Kate Kleimola. The Executive Director for Human Rights, Carolina Almonte, was present via Zoom. Councillor Zusy and Mayor Siddiqui were also present.

Chair Al-Zubi recognized Superintendent Wells for opening remarks (**Attachment B**). Superintendent Wells reviewed and summarized data related to ICE interactions from August 2025 to February 2026. This information was provided in advance of the meeting and included in the Agenda Packet. Superintendent Wells and Superintendent Cabral were available to respond to clarifying questions.

Chair Al-Zubi recognized Kate Kleimola who reviewed the City of Cambridge Welcoming Community Ordinance and the City Manager's Executive Order Prohibiting the Use of City Property for Civil Immigration Enforcement Activities, and Affirming the City of Cambridge Welcoming Community Ordinance and its Commitments to Public Safety and Public Trust. The Welcoming Community Ordinance was included in the Agenda Packet, and the Executive Order is attached (**Attachment C**). Carolina Almonte and her team provided a simple one-page summary of the Executive Order which has been translated into multiple languages, included in the attachment. The Law Department was available to respond to clarifying questions.

Chair Al-Zubi reviewed the outreach and feedback collected from community members and organizations regarding public safety concerns, fear within the community, and interactions with law enforcement. Chair Al-Zubi asked questions related to ICE activity on City owned properties, the City's response to protests, deescalation and force, documentations procedures, and chain of command requirements related to reporting. Superintendent Wells provided information related to the chain of command reporting and notification process, adding that command staff are to respond directly to the scene where ICE activity is occurring. Superintendent Wells and Deputy Superintendent Boyle provided an overview of the Police Department's experience related to protests and emphasized that the goal of the Department is to focus on public safety, deescalation, communication with organizers and protecting individuals of their First Amendment rights.

Chair Al-Zubi recognized Councillor Nolan who asked what kind of accountability ICE agents have if they get violent or damage property while in the city. Superintendent Wells and Kate Kleimola explained how those situations can become challenging because Federal Agents hold certain law enforcement powers, adding that each response would most likely depend on the specific circumstances of a situation. Kate Kleimola added that the City would use all legal avenues that are available to pursue accountability.

Chair Al-Zubi recognized Councillor Sobrinho-Wheeler who shared concerns related to an incident where a shoplifting incident resulted in an individual being taken into ICE custody and they were arrested and fingerprinted. Councillor Sobrinho-Wheeler acknowledged the importance of balancing public safety concerns and asked if CPD has explored different approaches and enforcement priorities in low level offenses, such as shoplifting, knowing that fingerprinting information connects individuals to a federal database. Superintendent Cabral shared that Cambridge has experienced more than 1,100 reported shoplifting incidents in 2025 and added that Officers do exercise discretion when determining if an arrest is necessary. Superintendent Cabral explained that many of those incidents result in the person being summonsed rather than arrested.

Chair Al-Zubi recognized Councillor McGovern who asked for more information related to the partnerships the City is making related to coordinating with nonprofit organizations and immigrant-support organizations. Megan Bayer and Carolina Almonte responded by sharing opportunities for training, outreach efforts, educational programming, bystander training, and informational sessions related to residents' rights. Carolina Almonte also provided information related to available interpretation services and multilingual outreach materials. Councillor McGovern asked how the City is working with Cambridge Public Schools as it relates to ICE interactions. Megan Bayer explained that City staff have shared available training and protocols with school leadership, adding that School Superintendent Murphy has also established procedures for staff.

Chair Al-Zubi recognized Councillor Simmons who thanked the Public Safety Department for their work and emphasized the importance of balancing public safety and community trust. Councillor Simmons shared concerns about relying on hypothetical scenarios and pointed out the challenges Officers face when they are responding to quickly evolving situations.

Chair Al-Zubi recognized Councillor Nolan who emphasized that many residents feel safe because of Cambridge's Welcoming Community Ordinance and the City's approach to immigration related issues. Councillor Nolan noted the importance of continuing to build trust in the community while also being prepared for incidents pertaining to ICE.

Chair Al-Zubi had clarifying questions related to an incident that occurred on October 29, 2025 outside of the Cambridge Police Department, where ICE detained a person leaving the Police Station after an arrest. Chair Al-Zubi also asked if there were any legal pathways or protocol changes that could be made so a similar situation does not happen again. Kate Kleimola explained that the City is not required to assist ICE, but cannot block federal agencies as well, noting that informing an individual or allowing them to leave through a different exit could be considered obstruction. Kate Kleimola also provided information on how CPD Command Staff and the Law Department are in constant communication with each other.

Chair Al-Zubi recognized Mayor Siddiqui who had follow up questions related to deescalation and deescalation training. Superintendent Wells explained that Officers have completed training exercises related to ICE scenarios and deescalation procedures. Mayor Siddiqui emphasized the importance of communication and coordination with the School Department, noting that information and resources have been shared with families and school staff. Mayor Siddiqui added that she would be happy to share those efforts with the full City Council.

Chair Al-Zubi asked for more information on signage on City owned property. Megan Bayer explained that the City Manager's Office and the Department of Public Works are in the process of identifying which properties will have signs installed based off the Executive Order. Chair Al-Zubi had additional questions related to public safety concerns, warrants by Federal Immigration Officials, and how the City reviews valid judicial warrants and nonjudicial federal immigration documents. Chair Al-Zubi added that it is important for the community to understand the difference between warrants and what actions can be taken. Superintendent Wells explained that CPD reviews all warrants that are presented by Federal authorities, adding that the Police Department would not act on a nonjudicial warrant.

Chair Al-Zubi offered closing remarks and emphasized the importance of continuing outreach and education efforts.

Chair Al-Zubi recognized Councillor Nolan who made a motion to adjourn the meeting.

OPENING REMARKS PSC-040726

Thank you, Madam Chair, and members of the Council, for the opportunity to address this important issue today. We understand the concerns, fear, and uncertainty that recent federal immigration enforcement activity may create for members of our community. I want to be clear that the Cambridge Police Department stands with our residents and remains committed to doing everything possible to support, protect, and assist them within the legal constraints that govern our authority and responsibilities. Our first priority is, and always will be, the safety and well-being of everyone who lives, works, studies, and visits the City of Cambridge.

Our officers operate in accordance with Massachusetts law, the City's Welcoming Community Ordinance, the City Manager's Executive Order, and established department directives. Within those boundaries, we work diligently to respond quickly, provide assistance, de-escalate situations whenever possible, and ensure that every person is treated with dignity, respect, and fairness. Just as important, we remain committed to maintaining the trust and confidence of the residents we serve. Today, we look forward to a discussion on issues that are important to the City, the Council, the Police Department, and the residents of Cambridge.

Executive Order Prohibiting the Use of City Property for Civil Immigration Enforcement Activities, and Affirming the City of Cambridge Welcoming Community Ordinance and its Commitments to Public Safety and Public Trust

WHEREAS, Cambridge is a city proud of its diversity, immigrant population, and its role as a welcoming community to people from around the world;

WHEREAS, the City Council designated Cambridge as a sanctuary city on April 8, 1985, and reaffirmed this designation in 2006, 2016 and as recently as 2024;

WHEREAS, On February 10, 2020, the City Council enacted its Welcoming Community Ordinance, and the Ordinance's stated purpose "is to establish the City of Cambridge as a Welcoming City, to declare that all are welcome here, and to increase public confidence in the City of Cambridge's government by establishing standards associated with the City's voluntary involvement in federal immigration enforcement";

WHEREAS, pursuant to the Welcoming Community Ordinance, the Cambridge Police Department shall not take part in or assist with federal immigration enforcement operations;

WHEREAS, the Cambridge Police Department has been recognized for its law enforcement accreditation by the Commission on Accreditation for Law Enforcement Agencies, its procedural justice and its community policing. The Cambridge Police Department is further recognized for its work keeping the community safe, and earning the community's trust and respect;

WHEREAS, the United States Department of Homeland Security's federal civil immigration enforcement surge operations have caused significant harm to local governments and their residents, including impacts on public safety, local law enforcement, and communities;

WHEREAS, the United States Department of Homeland Security's Immigration and Custom's Enforcement ("ICE") is not following current law enforcement best practices, including, but not limited to, agents are not wearing identifiable uniforms, all agents are not wearing and using body-worn cameras, agents are wearing face coverings, and agents are not identifying themselves;

WHEREAS, the Department of Homeland Security's actions violated residents' constitutional rights, have violated the United States Constitution by unlawfully occupying cities, and have perpetrated chaos and egregious acts of violence;

WHEREAS, it is necessary for the City of Cambridge to take action to protect its residents and to affirm its values and commitments enshrined in the Welcoming Community Ordinance;

WHEREAS, pursuant to the authority in the Charter of the City of Cambridge as set forth in Chapter 27 of the Acts of 2025, the City Manager is the Chief Executive of the City and is responsible for the administration of all City activities and City Departments including the Cambridge Police Department, implementation of all ordinances including the Welcoming Community Ordinance, and use of all City property;

NOW THEREFORE, I, Yi-An Huang, Cambridge City Manager, hereby order as follows:

1. Restriction on the Use of City Property

A. City Property Shall Not be Used for Civil Immigration Enforcement

No City-owned or City-controlled property, including parking lots, garages, parks, open space, or buildings, including the interior or exterior areas of any parcel upon which a building is located, shall be used as a staging area, processing location, operations base, or other supporting location for federal civil immigration enforcement. Prohibited uses include but are not limited to assembling, mobilizing, or deploying vehicles, equipment, materials, or personnel for the purpose of carrying out federal civil immigration enforcement operations. City-owned and City-controlled property is not available to the general public for similar activities; civil immigration enforcement operations are not an exception.

The City will identify all City-owned and City-controlled property that likely could be used for prohibited purposes described in this Section. The City will post signage on such City-owned or City-controlled property indicating that the property is owned and/or controlled by the City of Cambridge and may not be used for civil immigration enforcement purposes.

The City will make template signage available to private property owners and leaseholders who seek to restrict private spaces from being used for civil immigration enforcement purposes. Property owners and leaseholders assume any legal responsibility associated therewith.

B. Protecting Residents in City Buildings

Consistent with the Welcoming Community Ordinance (the “Ordinance”) and the City’s practices, the City shall not allow civil immigration enforcement officials into nonpublic spaces without a valid judicial warrant or court order. The City reaffirms its position that City buildings are available to provide specific services to members of the public and to conduct City operations and are to be accessed for those purposes only. In the event that City staff is approached by federal immigration agents, staff should refer to the City Procedures to Response to ICE in City Buildings.

2. Ensuring Public Safety

A. Cambridge Police Department Shall Ensure Public Safety On Scene

Pursuant to Ordinance Section 2.129.040(J), the Cambridge Police Department (“CPD”) shall not participate in federal civil immigration enforcement operations and shall ensure public safety. Community members who believe they observe ICE activity are encouraged to call 9-1-1 immediately; a prompt local police response is important to assess the scene and ensure safety. CPD shall perform actions and services deemed necessary to ensure the safety of all on scene. Pursuant to the Ordinance and established CPD policies and practices, these actions and services shall include ensuring the safety of protestors and protecting individuals’ rights of assembly and free speech. CPD shall work with other City first responders, including the Cambridge Fire Department and Cambridge Community Safety Department, and shall summon emergency medical services when necessary.

B. CPD Intervention and Investigation of Criminal Conduct by Federal Officials

Consistent with Massachusetts Police Officer Standards and Training (POST) regulation 555 CMR 6.06 and CPD Policy No. 1-2, if any CPD officer observes any law enforcement official using or attempting to use physical force, including deadly force, beyond that which is necessary or objectively reasonable based on the totality of circumstances, the CPD officer shall intervene to prevent the observed official’s use of unnecessary or unreasonable force, regardless of the rank of the observed official or the agency for which the official works, unless intervening would result in imminent harm to the CPD officer or another identifiable individual.

Pursuant to state law and established CPD policies and practices, CPD shall investigate all allegations of violence, property damage, and criminal conduct, including by federal officials. Such investigations shall be independent of parallel federal investigations, if any; and CPD shall, whenever appropriate, work in collaboration with and make referrals to the Middlesex County District Attorney or the Massachusetts Attorney General.

C. CPD Response to Suspected Trespassing

The City will issue communications to residents, through all available channels, that, consistent with its statutory authority and longstanding practice, CPD shall respond promptly to calls for service reporting attempted intrusions onto private property by those with no legal right of entry; and that calling 9-1-1 is an appropriate response to any attempts by unidentifiable individuals, including those who claim to be federal officials but have not provided identification, to enter a private residence without a warrant.

If CPD is able to verify the individuals as federal civil immigration enforcement officials, CPD shall document the activity on scene, including any entry onto private property, forced or otherwise, and any detention of individuals, pursuant to Ordinance Section 2.129.040(K). CPD shall also employ de-escalation tactics in response in order to ensure safety of all those present.

3. Ensuring Public Trust

A. Documenting Federal Action and Release of Video Footage

As stated above, pursuant to the Ordinance Section 2.129.040(K), if CPD is dispatched to the scene of federal immigration enforcement action, CPD shall take reasonable steps to verify that the individuals on scene are federal agents conducting federal civil immigration enforcement. CPD shall document the activity on scene and document any identification information provided by federal officers or agents.

CPD shall work with the City Solicitor's Office to publicly release video footage of violence or property damage by federal officials captured by CPD body-worn cameras or other City-controlled surveillance cameras. Such release may be subject to a determination that the release of such information or footage will not prejudice the possibility of effective law enforcement and that such disclosure is in the public interest, pursuant to G.L. c.4, §7(26)(f).

B. Pursuit of Legal Remedies

The City Solicitor's Office shall pursue all available legal avenues to contest federal actions that violate the rights of residents or the City.

4. Scope

This Order reinforces and affirms the City's emphasis upon providing for the public safety of the City's residents and its workforce; nothing in this Order shall be interpreted to restrict or interfere with the lawful conduct of civil immigration enforcement, the enforcement of criminal law, nor as limiting the rights of any person or entity under state or federal law. Nothing in this Order shall be interpreted to instruct local law enforcement officials or other City employees to interfere or otherwise take any action that might aggravate an interaction involving federal officials and/or cause harm, nor shall it be interpreted to confer upon any local law enforcement officers or City employees the authority, obligation, or responsibility to enforce, interpret, supervise, assess compliance with, or prevent conduct governed by this Order.

This Order shall take effect immediately and remain in effect until further notice.

Cambridge Executive Order & Prohibited Civil Immigration Enforcement Activities

In January 2026, City Manager Yi-An Huang signed an Executive Order prohibiting the use of City property for civil immigration enforcement activities and affirming the City's Welcoming Community Ordinance.

This order is meant to keep people safe, protect community rights, and clarify how federal immigration enforcement can and cannot interact with City spaces.

What You Need to Know

City property cannot be used to stage civil immigration enforcement

Federal immigration officers cannot use City property to carry out their operations.

Federal immigration officers cannot enter the private areas of City property without permission

Federal immigration officers cannot enter areas of City buildings that are not open to the public unless they have a valid warrant or court order.

Cambridge Police do not enforce federal civil immigration laws

Cambridge Police will not take part in federal civil immigration enforcement. Their role is to keep everyone safe and protect the right to free speech and peaceful protest. There are many Cambridge Police partners with federal law enforcement agencies to enforce criminal laws.

If you see possible ICE activity, call 911

If you believe you are seeing immigration enforcement activity, call 911 so Cambridge Police can respond, verify what is happening, and keep everyone safe.

Accountability and transparency

If federal immigration officers use force or damage property, video footage from body cameras may be released unless it is part of an active investigation.

All crimes will be investigated

Cambridge Police will investigate any violence, property damage, or possible crimes, including those involving federal immigration officers. They will work with state officials like the District Attorney's Office and the Attorney General's Office when needed.

Cambridge Executive Order & Prohibited Civil Immigration Enforcement Activities

In January 2026, City Manager Yi-An Huang signed an Executive Order prohibiting the use of City property for civil immigration enforcement activities and affirming the City's Welcoming Community Ordinance.

This order is meant to keep people safe, protect community rights, and clarify how federal immigration enforcement can and cannot interact with City spaces.

What You Need to Know

City property cannot be used to stage civil immigration enforcement

Federal immigration officers cannot use City property to carry out their operations.

Federal immigration officers cannot enter the private areas of City property without permission

Federal immigration officers cannot enter areas of City buildings that are not open to the public unless they have a valid warrant or court order.

Cambridge Police do not enforce federal civil immigration laws

Cambridge Police will not take part in federal civil immigration enforcement. Their role is to keep everyone safe and protect the right to free speech and peaceful protest. There are many Cambridge Police partners with federal law enforcement agencies to enforce criminal laws.

If you see possible ICE activity, call 911

If you believe you are seeing immigration enforcement activity, call 911 so Cambridge Police can respond, verify what is happening, and keep everyone safe.

Accountability and transparency

If federal immigration officers use force or damage property, video footage from body cameras may be released unless it is part of an active investigation.

All crimes will be investigated

Cambridge Police will investigate any violence, property damage, or possible crimes, including those involving federal immigration officers. They will work with state officials like the District Attorney's Office and the Attorney General's Office when needed.

Agentes federais de imigração não podem entrar em áreas privadas de propriedades públicas da Cidade sem permissão

Agentes federais de imigração não podem entrar em áreas de edícios da Cidade que não sejam abertas ao público, a menos que possuam um mandado ou ordem judicial válidos.

A Polícia de Cambridge não aplica as leis federais de imigração civil

A Polícia de Cambridge não parcipará da fiscalização federal de imigração civil. O papel deles garanr a segurança de todos e proteger o direito à liberdade de expressão e ao protesto pacífico. Há momentos em que a Polícia de Cambridge trabalha em conjunto com agências federais de aplicação da lei para fazer cumprir as leis criminais.

Se você vir uma possível avidade do ICE, ligue para o 911

Se você acredita estar presenciando uma avidade de fiscalização de imigração, ligue para o 911 para que a Polícia de Cambridge possa responder, verificar o que está acontecendo e garanr a segurança de todos.

Responsabilidade e transparência

Caso agentes federais de imigração usem força ou danifiquem propriedades, as imagens das câmeras corporais poderão ser divulgadas, a menos que façam parte de uma invesgação em andamento.

Todos os crimes serão invesgados

A Polícia de Cambridge invesgará qualquer ato de violência, dano à propriedade ou possível crime, incluindo aqueles que envolvam agentes federais de imigração. Eles trabalharão com autoridades estaduais, como a District Attorney's Office (Promotoria de Jusça) e a Attorney General's Office (Procuradoria-Geral), quando necessário.

Orden ejecuta de Cambridge y actividades prohibidas de control civil de inmigración

En enero de 2026, el City Manager, Yi-An Huang, firmó una orden ejecuta que prohíbe el uso de propiedades de la ciudad para realizar actividades de control civil de inmigración y reafirma la Welcoming Community Ordinance (Ordenanza de comunidad de bienvenida) de la ciudad.

Esta ordenanza tiene como fin mantener la seguridad de las personas, proteger los derechos de la comunidad y aclarar cómo las fuerzas federales de inmigración pueden y no pueden interactuar con los espacios de la ciudad.

Lo que debe saber

Las propiedades de la ciudad no pueden usarse para realizar actividades de control civil de inmigración

Los agentes federales de inmigración no pueden usar la propiedad de la ciudad para llevar a cabo sus operaciones.

Los agentes federales de inmigración no pueden entrar en áreas privadas de las propiedades de la ciudad sin autorización.

Los agentes federales de inmigración no pueden entrar en áreas de los edificios de la ciudad que no están abiertas al público, a menos que tengan una orden judicial válida o una orden del tribunal.

La policía de Cambridge no hace cumplir las leyes federales civiles de inmigración.

La policía de Cambridge no participará en el control federal civil de inmigración. Su función es mantener a la comunidad a salvo y proteger el derecho a la libertad de expresión y a la protesta pacífica. Hay ocasiones en que la policía de Cambridge colabora con agencias federales del orden público para hacer cumplir las leyes penales.

Si ve posible actividad de ICE, llame al 911

Si cree que está presenciando actividad de control de inmigración, llame al 911 para que la policía de Cambridge pueda responder, verificar lo que está sucediendo y mantener a todos a salvo.

Responsabilidad y transparencia

Si agentes federales de inmigración usan la fuerza o dañan la propiedad, las grabaciones de vídeo de las cámaras corporales pueden hacerse públicas, a menos que formen parte de una investigación activa.

Todos los delitos serán investigados

La policía de Cambridge investigará cualquier acto de violencia, daño a la propiedad o posible delito, incluidos los que involucren a agentes federales de inmigración. Se trabajará con oficinas estatales, como la District Attorney's Office (Oficina del Fiscal de Distrito) y la Attorney General's Office (Oficina de la Fiscalía General), cuando sea necesario.

Cambridge 行政命令：禁止进行民事移民执法活动

2026 年 1 月，City Manager Yi-An Huang 签署一项行政令，禁止将市属财产用于民事移民执法活动，并重申本市的《欢迎社区条例》。

该行政令旨在保障民众安全、保护社区权利，并明确联邦移民执法部门可以或不可以与本市场所发生接触及开展执法活动。

须知

市属财产不得用于任何民事移民执法活动

联邦移民官员不得利用市属财产开展执法行动。

联邦移民官员不得未经许可进入市属财产的私人区域

除非持有有效的搜查令或法院命令，否则联邦移民官员不得进入市属建筑中不对公众开放的区域。

Cambridge 警察不负责联邦民事移民法律的执法

Cambridge 警察不会参与联邦民事移民执法。该部门的职责是确保公众安全，并保护言论自由与和平抗议的权利。在个别情况下，Cambridge 警察会与联邦执法机构合作，执行刑事法律。

发现疑似 ICE 活动请拨打 911

如果您认为自己目睹了移民执法活动，请拨打 911，Cambridge 警察将做出响应、核实情况并确保所有人安全。

问责制与透明度

若联邦移民官员使用武力或损坏市属财产，执法记录仪的录像将予以公开（正在进行的调查除外）。

所有犯罪行为都将受到调查

Cambridge 警察将调查任何暴力、财产损失或可能的犯罪行为，包括涉及联邦移民官员的案件，并在必要时与 District Attorney's Office（地方检察官办公室）、Attorney General's Office（州检察长办公室）等州级官员合作。
